**Doug Zuehlsdorf reported on the banquet/fundraiser. He reported it was one of, if not the best fundraiser to date, the club netted close to \$ 20,000 fro the event according to Carl Berg, Treasurer. Doug also indicated that he and Will have developed a manual as a guide for planning any future banquets.**

**Bonnie Conrad reported the Firearms Safety Range Day was held on May 2 , with 12 attendees, as previously reported the group from Hackensack had a conflict and held a separate range day. Comments from attendees and their parents were quite complimentary.**

**The Leech Lake Township representative informed us that it was their desire, depending upon property owners concurrence, that Rifle Range Road be blacktopped , at a cost of approximately \$ 50,000. The board made inquires about the nature and timing and concluded that the Clubs position was favorable toward a blacktopping limited to the club not having an assessment to exceed \$ 4,000.**

**Dan Smith informed the club that the new pistol range structure would be approximately 20x20, with a slab of approximately 20x40, at a cost of approximately \$ 5,000. In addition the existing structure would be improved by re-doing the front siding facing the clubhouse.**

**Carl Berg requested authorization to purchase a JD mower from Walker Implement and was authorized to purchase a mower with extra blades, at a cost of approximately \$ 5,000.**
