ASSUMPTION OF RISK, RELEASE & INDEMNITY AGREEMENT

I ASSUME THE RISK, AND RELEASE, AND WILL DEFEND THE CLUB FOR WHAT I DO AND WHAT HAPPENS TO ME.

I assume the risk of taking part in activities at the Northstar Shooting Sports Club, located at 10215 Rifle Range Drive NW, Walker, MN 56484.

I acknowledge the hazards involved in shooting activities, both known and unanticipated. In particular, I accept the risk of injury from the use of firearms and/or archery equipment caused by me or by others.

I AGREE TO ACCEPT AND ASSUME ANY AND ALL RISKS EXISTING ON THE PREMISES, AND IN ENTERING ONTO AND IN USING THE SHOOTING RANGE AND OTHER FACILITIES ON THE PREMISES, OR EQUIPMENT PROVIDED BY NORTHSTAR SHOOTING SPORTS CLUB, AND IN ENGAGING IN OR OBSERVING SHOOTING OR OTHER ACTIVITIES ON THE PREMISES.

Further, I accept and assume responsibility and liability for any negligent, reckless, or criminal act, or omission to act, of myself or my guests at the premises. A "Guest" shall be anyone who is not a member of Northstar Shooting Sports Club and who enters the premises in the company of or as a result of the Undersigned's invitation, permission, or consent.

Further, I accept that if I am a Non-member user, I will be held to the same standard of behavior as a member user.

Further, I agree to accept and assume all responsibility for and to hold harmless and defend Northstar Shooting Sports Club, Inc., from any and all fault, liabilities, costs (including the cost of any settlement or judgement, costs of court, and attorneys' fees), expenses, claims, demands, and lawsuits connected with my actions or omissions, or those of my guests.

Further, I agree not to sue Northstar Shooting Sports Club, or any of their respective employees, directors, officers, agents, and volunteers for any and all claims, of any kind whatsoever from my engaging in or observing shooting and other activities at the premises.

I agree that I will abide by all Northstar Club rules and regulations, any rules or procedures applicable to any particular activity, safety rules, and obey all instructions of Northstar Shooting Sports Club's employees, and:

I SHALL WEAR APPROPRIATE EAR AND EYE PROTECTION AT ALL TIMES WHEN PARTICIPATING IN OR OBSERVING SHOOTING OR OTHER ACTIVITIES.

This Agreement shall be interpreted and enforced under the laws of the State of Minnesota and shall be applicable to each and every occasion that the Undersigned, individually, or as a guest, enters on to the Premises. If the Undersigned is a minor, the signature of a parent, legal guardian, or supervising adult, as to such minor, must accompany the signature of the minor.
